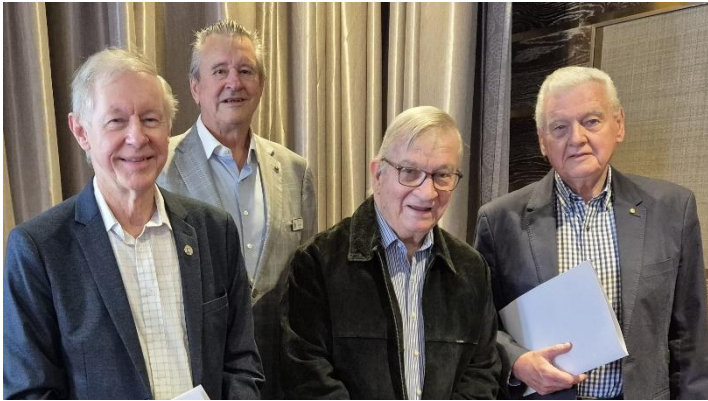

## GOLDEN VALE HOMESTEAD



A special visit has been arranged to the historic homestead of Golden Vale at Sutton Forest on Thursday, 22<sup>nd</sup> May.

Golden Vale was home to many owners over the years. The land was first promised to free settler Michael Hogan, who sold Golden Vale to emancipated convict Thomas Wilmot in 1830 for 39 pounds. Edward Carter later purchased Golden Vale from Wilmot in 1857 and built the grand homestead to house his growing family.

The homestead features an extensive collection of furniture and art, as well as outbuildings dating from the nineteenth century, including stables and woolshed.

The day will start with morning tea at 10:30 and then a guided tour at 11 o'clock. Lunch will be at the Sutton Forest Inn at 12:30.
